WAIVER, RELEASE AND AUTHORIZATION

I am voluntarily entering or agreeing to be a volunteer at American Trucking Associations (“ATA”)’s 5K Fun Run/Walk (“Event”) in Austin, Texas. I know that running/walking in such an Event is a potentially hazardous activity. I agree not to enter and participate in the Event (as runner, walker or volunteer) unless I am medically able and properly trained. I agree to abide by any decision of Event officials relative to safely completing the Event. I assume all risks associated with running in the Event including, but not limited to: injuries, falls, contact with other participants, debris, overhead objects, vehicles, traffic, the effects of weather (e.g., heat, humidity, and rain), and conditions of the road/surfaces, all risks being known and appreciated by me. Having read this Waiver and knowing these facts, and in consideration of ATA’s acceptance of my entry into the Event, I, for myself and anyone entitled to act on my behalf, intend to be legally bound, and do hereby, for myself, my heirs, executors and those entitled to act on my behalf, waive and release “ATA”, Event sponsor(s), Event beneficiary(ies), and any and all subsidiaries, divisions, officers, directors, agents, employees, successors, and assigns of ATA, Event sponsor(s), or Event beneficiaries, and any and all Event volunteers, officials and participants (collectively, the “Releases”), from present and future claims and liabilities of any kind, known or unknown, arising out of my participation in the Event. Such waived/released claims and liabilities may include those for or related to damages for personal injury and/or property damage either sustained or suffered by me or accrued to me, and/or any claim of right with respect to the Images (as defined below), including but not limited to claims of false endorsements, or of publicity or privacy, even though such claim or liability may arise out of negligence or fault on the part of any of the Releases. I further acknowledge that ATA reserves the right to change the details (e.g., the date, start time, course, and distance) of the Event at any time for any reason and I hereby waive and release any claims that I may have as a result of such change. If I should suffer injury or illness, I authorize the officials of the Event to use their reasonable discretion to arrange qualified medical assistance deemed necessary or appropriate to address such injury or illness and/or to have me transported to a hospital or other medical facility, and I take full responsibility for these actions. I attest and certify that I am physically fit and have sufficiently trained to participate in the Event. I acknowledge and accept that bicycles, baby strollers/joggers, dogs, inline/roller skates, and headphones are prohibited. I hereby grant full permission and the irrevocable and assignable right to the Releases to depict in perpetuity, worldwide, and in any all media now or hereafter known, my likeness, image, name, words, voice and/or any recordings of the Event in which I might appear (collectively, the “Images”) in photographic works, motion pictures, video recordings and/or other works, and I agreed that such Images may be used by the Releases for any legal purpose without compensation.
